- Beginning on Friday, April 1, 2022 through Saturday, June 25, 2022, drawings will be held every Friday and Saturday at 7:00 p.m. at the Promotions Stage.
- Beginning on Saturday, March 26, 2022 at 8:00 p.m. through Saturday, June 25, 2022 at 6:59 p.m. every Thunder Rewards member can earn one (1) free daily electronic drawing entry. Slot players can earn one (1) electronic drawing entry for every 250 points earned on their Thunder Rewards Card. In addition, every Table Games player can earn one (1) electronic drawing entry for every 100 points earned on their Thunder Rewards Card.
- Every Monday and Friday, Thunder Rewards members can earn Double Drawing entries from 12:01 a.m. – 11:59 p.m.

Electronic Entry Claiming Procedures

- One (1) free daily electronic entry must be redeemed at the Self-Service Kiosk each day before 11:59 p.m.
- Earned entries are only accumulative through the week and must be activated on the drawing date for that week to be included in the electronic drawing.
 - Earned entries accumulate weekly starting on Saturday at 7:00 p.m. through the following Saturday at 6:59 p.m. These weekly earned entries will only accrue and be active for the Friday and Saturday electronic drawings held on the week that the entries are earned and accrued.
 - Entries earned and accrued after 7:00 p.m. on Saturday evening will be valid for the electronic drawings held the following weekend.

- Beginning on Saturday, March 26, 2022 at 8:00 p.m. through Saturday, June 25, 2022 at 6:59 p.m., two (2) electronic drawing entries will be awarded for every 250 Slots points earned on the guest's Thunder Rewards Card on Monday and Friday.
- Beginning on Saturday, March 26, 2022 at 8:00 p.m. through Saturday, June 25, 2022 at 6:59 p.m., two (2) electronic drawing entries will be awarded for every 100 Table Games points earned on the guest's Thunder Rewards Card on Monday and Friday.
- Issuance of electronic entries will cease at 6:59 p.m. on Saturday, June 25, 2022.

Drawing Procedures

- At each scheduled drawing time, seven (7) electronic entries will be drawn using a certified random number generator within the Drawing Manager program. Each winner's first name and Thunder Rewards Card number will be announced and displayed electronically throughout the casino. Announcements cannot be heard in restaurants or restrooms.
- Winners must be present and have their Thunder Rewards Card and ID verified by the Promotions Representative at the stage within three (3) minutes after their card number has been displayed. Winners must have their Thunder Rewards Card and valid ID to claim their prize.
- If prize remains unclaimed after the allotted time period, the prize is considered forfeited and additional individual entries will be randomly selected in accordance with the procedures listed above.
- At each drawing, in the order in which the seven (7) guests are drawn, guests will be asked to select a token.
